## (10).SPECIAL ACHIVEMENT DURING THE MONTH OF AUGUST' 2008:-

On 14.08.2008 while RPF Head Constable 6090 J.Rai and Head Constable 8912 O.P.Yadav of RPF/Post/Muri were on duty at Railway station Muri from 00.00 hrs to 08.00 hrs received information from the victim named as Raju Mahato S/O Sri. Dilip Mahato of Vill-Bagalia, PS+Dist-Purulia about his pick pocketing of money purse containing of Rs. 300/-. On the identity of wearing apparels of the culprit disclosed by victim, both the RPF staff conducted search along with Sri. Paswan the shift officer of GRPs/Muri and they could be able to detect the person with full recovery of stolen materials and apprehended him. The arrested culprit also confessed his guilt. In this regard, GRPs./Muri has registered case No. 13/08 dtd. 14.08.2008 U/S 379 IPC/411 IPC against the arrested person and forwarded him to the court of Railway magistrate/Ranchi.

The case is under investigation with GRPs/Muri.
